Hi Claire.

Our tree surgeon finally got along to see the leaning conifer tree which is leaning over the rear boundary of Savoy Court (17 Branch Hill).

Due to the small root system on this tree, it's height and age, the recommendation is for it to be felled. Our tree surgeon also recommends that Ivy be severed to trees in the immediate area as well.

To fell, remove cuttings and cut through ivy at ground level to other trees (leaving Ivy on the trees to die and fall naturally), we have his quotation of £ 450 + vat

He is sure we will need to contact the council planning dept for permission. He spoke with the lady at 17 Branch Hill and she said that she would be contacting the council I believe.

You mentioned that you had a contact in planning? I will be pleased to make the application on your behalf to have the tree felled if you wish. Just let me know.

Once permission has been granted, which I am sure it will be two can instruct our tree surgeon to carry out.
