Amendment to Planning Permission 2010/0011/P (granted 17/03/2010) for change of use of part ground floor from office use (Class B1) to retail use (Class A1), and alterations including installation of new shopfront to South elevation and replacement of exit door to North elevation. Amendment comprises installation of obscure glazed panel at ground floor level on Shaftesbury Avenue elevation.

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy B1 (General design principles) of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan; D1-010; D1-020; D1-110; D1-120; D1-200; D0-050A; D0-070A; 0591.

Reason: For the avoidance of doubt and in the interest of proper planning.
