2 All new external and internal works and finishes and works of making good to the retained fabric, shall match the existing adjacent work with regard to the methods used and to material, colour, texture and profile, unless shown otherwise on the drawings or other documentation hereby approved or required by any condition(s) attached to this consent.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.

Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council in consultation with English Heritage before the relevant part of the work is begun:

a) Samples of materials (timber, glazing and paint finishes where appropriate to exposed metal frame) in respect of facing materials to the new mezzanine extension. These should be provided on site and retained on site during the course of the works.

b) Structural engineer's method statement detailing methods of construction, and safety precautions on site to ensure no damage occurs to existing historic fabric during construction.

The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.
