External alterations at ground floor level including the replacement of existing window and stallriser and the insertion of new door and fanlight on the Warner Street elevation to existing public house (Class A4).

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 The development hereby permitted shall be carried out in accordance with the following approved plans - Site Location Plan; 5552-10-200 A; 202 A; 203 B; 205; 207; 208 A; 209 A.

Reason: For the avoidance of doubt and in the interest of proper planning.

- 1 Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. - Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. No. 020 7974 5613 or by email ppp@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- 3 Reasons for granting permission. [Delegated]

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies B1 (General design principles), B4 (Shopfronts, advertisements and signs), B7 (Conservation areas) and B6 (Listed buildings). For a more detailed understanding of the reasons for the granting of this planning permission, please refer to the officers report.

4 Notwithstanding the information shown on the submitted drawings for external alterations hereby approved, this decision relates only to the new fire safety doors on Warner Street elevation. You are advised that any alterations to the entrance door on Mount Pleasant, as indicated on drawing no. 5552 -10-205, will require further planning permission and listed building consent.
