## Site Description

Retail units located on the west side of Monmouth Street. The site forms part of a row of three grade II listed terraced houses with later shops. No.14 with mid C19 wooden shopfront with arched lights to shop window. The site is within Seven Dial Conservation Area.

## Relevant History

19/08/2008- planning permission and lbc **GRANTED** - Installation of an awning to the shop fronts of nos. 14, 16, and 18 Monmouth Street. (ref: 2008/3404/L/ 20082949/P)

22/12/2008 **GRANTED** - Details of colour, appearance and materials for the awning of no. 14 Monmouth Street pursuant to the partial discharge Condition 4 attached to listed building consent granted on 19th August 2008 (ref: 2008/3404/L) for installation of an awning to the shop fronts of nos. 14, 16, and 18 Monmouth Street. (ref: 2008/5066/L)

09/02/2010 **GRANTED** Details of colour and materials of awning at No.16 only pursuant to condition 4 of listed building consent dated 19 August 2009 (ref. 2008/3404/L) for the installation of an awning to the shop fronts of nos. 14, 16, and 18 Monmouth Street. (ref: 2010/0052/L)

## Assessment

Consent is sought to partially discharge condition 4 (Details of colour, appearance and materials for the awnings) of listed building consent dated 19/08/2008 (Ref: 2008/3404/L)

The proposed colour, appearance and materials to be used for the awning at no.18 include;

- Teflon coated canvas awning material with hanging valence and floral motif.

The proposed colour and use of material for the awning are considered historically appropriate for the age and style of the shop front and are therefore is considered to preserve the special character of the listed building. The fun yet subtle floral motif is considered to relate to the nature and character of the street and Seven Dial Conservation Area without unduly harming the character of the listed building.

The work is considered to comply with the relevant policies and the partial discharge of the conditions is recommended for approval.
