Proposal:

Alterations to rear mansard roof reducing the size of the existing terrace and alterations to fenestration; insertion of green roof to existing flat roof at rear second floor level; replacement of existing doors and windows at rear ground floor level, installation of new spiral staircase from garden to existing rear ground floor level terrace; and insertion of 2 rooflights to front roof slope of dwelling house (Class C3).

Conditions and Reasons:

- The development hereby permitted must be begun not later than the end of three years from the date of this permission.
 - Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).
- All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.
 - Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1 (General design principles) and B7 (Conservation areas) of the London Borough of Camden Replacement Unitary Development Plan 2006.
- The development hereby permitted shall be carried out in accordance with the following approved plans: Site location plan; 01; 02; 03; 04; 05; 06; 174 P/01 rev A; 02 rev A; 03 rev A; 04 rev A; 05 rev A; 06 rev A; 07 rev A; 08 rev A; 09 rev A; 10 rev A; 11 rev A; 12 rev A; 13 rev A; 14 rev A; 15 rev A; 16 rev A; 17 rev A; 18 rev A; 19 rev A; excerpt from Sky-Garden green roofs.

Reason: For the avoidance of doubt and in the interest of proper planning.

You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Planning and Public Protection Division (Compliance and Enforcement Team), Camden Town Hall, Argyle Street, WC1H 8EQ (Tel. 4 Reasons for granting permission.
