Rear Garden

Magnolia Grandiflora - Judiciously reduce crown by aprox 15-20% as general maintenace.

Plum Suckers - Reduce by 20% to tidy and general maintenance.

Lime - (Overhanging from neighbouring garden) - Judiciously reduce overhang by 15-20% to control encroachment.

Front Wall:

Wisteria - Trim long leaders back into main framework and check stem to the right of the building, nearest entrance, is secure. Sever all stems growing up gutter drain pipe at height of trellis in order to halt further growth above trellis height and encroachment onto roof.
