UCS intends to carry out online pupil surveys once a year during a set week in October to avoid errors caused by differences in seasonal travel patterns. The School will also carry out annual staff and parent surveys. The staff survey will show how staff travel to work and how their journeys can be improved. As well as gathering hard data about travel patterns, the parent survey will focus on parents' views on the journey to School and what they think about recently implemented initiatives.

The School is also committed to annually update the School Travel Action Plan document as described below.

Annual summary

An annual summary will be produced in line with Camden's current data requirements. The annual summary will be added to the Travel Plan as an annex, providing an overview and an easily accessible history of Travel Plan work. The annual summary will be in tabular format in two parts: measures carried out, and a follow up of targets. There will also be an Evidence Portfolio which is added to throughout the year. This can be used for inspections,

The table summarising measures carried out will identify all the initiatives that the Travel Plan has contributed during the year, and will constitute the ongoing Travel Action Plan. For each measure listed, it will be noted if the measure is considered successful or not. If unsuccessful, a note will state why and what could have been done differently. For each measure, progress against the target will be assessed. If a target is not reached, notes will be included explaining why and what the School might have done differently.

Kenneth Durham, Headmaster



When University College School was founded in Gower Street in 1830 as part of University College, the first and over-riding aim was to promote principles of liberal scholarship. This is as true today as it was then. Intellectual curiosity, breadth of study and independence of mind combine to achieve academic excellence; they are not subordinate to it.

UCS has always been proudly inclusive in terms of race and creed. The School seeks to foster in its students a sense of community and a respect for others, alongside a tolerance of and sensitivity to the individual. This is central to our ethos. We recognize now, at the start of our second century in Hampstead, that, for today's young people, such a sense of community and of social and individual responsibility must include a full understanding of the environmental and personal impact of private travel choices.

This School already does much, both in academic and in pastoral terms, to promote awareness of the environment amongst the pupils and to encourage them in adopting a healthy life style, for themselves and others.

The governors and managers of UCS have decided now that we should take this a further step, building a commitment to the reduction of School-related traffic into all of our future Development Plans. This first UCS Senior School Travel Plan (the first such Plan for any Secondary School in Hampstead) represents just the first stage in our desire to educate the entire UCS community in the huge importance of personal travel choices for the long-term health and safety of themselves and of the wider community.

We cannot achieve this alone. We will require the support of students and staff and their families. Just as important will be the cooperation and support of Camden, Transport for London, the Police and other local services. Together, we can make a difference.

A further Hands Up Survey was held in February 2008 (29.2.2008) with 610 of the 743 pupils taking part.

Who was surveyed? All UCS Senior School pupils and their parents were asked to complete the survey, which was conducted in November 2006.

What was the response rate? 537 pupils answered the survey (out of a possible 743). 225 parents answered the survey, which is a significantly smaller proportion than pupils, but a large enough sample on which to conduct analysis.

How was the survey undertaken? The survey was conducted online through the community website Cityneighbours.com


What type of survey was used? The survey was designed according to standard market research guidelines and examined how students currently travel to School, as well as their parents' attitudes to the different forms of transport available. It gave parents the opportunity to comment on their particular situation.

Concerns About The School Trip And Safety. Parents provided a wealth of qualitative data, suggestions and ideas in the survey. A copy of comments concerning safety and a potential School Bus is available from the School.

Parent, Pupil & Staff Survey Feedback and Analysis. A detailed breakdown of the responses from pupils explaining why they do not use various modes of transport, and what might encourage them to change their preferred mode of transport can be found as Appendix 3. Appendix 4 deals with responses from parents, primarily regarding car sharing and public transport, as well as their feelings on a possible School bus for UCS Senior School. Appendix 5 deals with staff survey feedback.

This chart shows the proportion of pupils living within certain distance ranges from the School.








The greatest problem facing pupils walking to school would at first appear to be the load they carry. In a separate question, over 39% of pupils reported having to carry books, equipment and/or heavy instruments that are too heavy, big or very awkward to get to School with them more than once a week.

However, as Questions 34 and 35 indicate below, personal safety is a much greater factor than it first appears to be here, which would explain why "police presence" and "safer roads" are such significant answers in Question 13.

Most of the qualitative comments made by pupils regarding walking dealt with the distance being too great. This is not surprising given that 73% of UCS's pupils live more than one mile away from the School and nearly 40% live beyond two miles.



As it currently stands, most pupils do not feel safe on the road, but would if dedicated bicycle lanes were made available and other measures were taken which reduced their perception that the roads were dangerous. These might include careful selection of routes and training to cope with traffic conditions. Pupils also commented that they would be encouraged to cycle if there was safe and secure cycle storage and if they had access to larger lockers.

Question 34 (below) points out that most pupils have been involved in a near-miss traffic accident during the School year, either while walking or cycling, which indicates that this may not be a safe option.


Qualitative comments regarding cycling were mostly concerns of a road-safety nature, as well as a number of pupils who do not own a bike, or are too concerned their bike would be stolen.



Clearly the main complaint with public transport is overcrowding, both in the bus and on the streets. The time when pupils are going to school is when most people are going to work, and pupils don't seem to feel there are enough buses to cope, and that the overall increase in traffic results in a much longer trip to School. Opinions on how to encourage public transport use seems to be evenly spread, however.

Most of the qualitative statements made by pupils were of a general concern for safety.




Question 34: Have you been involved in any of the following problems either TO or FROM school in the past year?

The above chart indicates that most pupils have had some form of distressing situation during the school year, the most common of which appear to be traffic related or personal safety. Most of those answering "Other" reported being mugged or attempted muggings.



Question 35: If you were involved in any such incident, how were you travelling?



The vast majority of those involved in these incidents were either walking or taking some form of public transportation. As this is a very significant find, we have broken the numbers down further:

- Of the 101 pupils involved in a near-miss accident, 45 (44.5%) were walking. The other 56 were almost evenly split between taking the bus, train, car or bicycle.
- Of the 90 pupils involved in a mugging, 58 (64.4%) were walking. Most of the others took public transportation.

- Of the 42 pupils who were bullied or harassed, 26 (61.9%) were walking. Most of the others took public transportation.
- Of the 95 pupils who were approached by a stranger, 47 (49.5%) were walking. Most of the others took public transportation.
- Of the 54 pupils who got lost, 31 (57.4%) were walking. Most of the others took public transport.


Appendix 4: Parent Survey: Feedback and Analysis


Many of the respondents had personal reasons for not being involved in a car share; namely either having a carload of children already or having to get to work. It is unlikely that anyone from these groups can be convinced to car share. However, a significant portion indicated they either didn't know who to approach or found the matter too inconvenient, which we hope the School Journeys program will be able to assist in. Most of those responding "other" indicated that they do not drive to School on a regular basis, only occasionally.




Question 13: Would you be interested in a School bus program provided by UCS?


Though most answered No, there seems to be enough support for three buses. Please note that only 225 parents (out of 743 pupils) answered this question, so number of parents who might be interested could be much higher.

Most of those not interested in a school bus program were already happy with their current travelling to school arrangements. Those that gave other answers mostly focused on cost issues (buses are free, school bus would be too expensive, tube is less expensive, etc.) Some noted that due to after-school activities many pupils have, a return school bus home might not be viable.





Question 19: What do you estimate your current cost of travel to and from school to be?



The above two charts indicate the reason more parents are not interested in school bus. The minimum cost projected by UCS at this time is £30 per week, while most responding parents feel they pay less than that already. The fact that around 60 parents in this sample would consider paying more in exchange for the safety and convenience of a dedicated school bus is significant.
