Conditions and Reasons:

The development hereby permitted must be begun not later than the end of three 1 years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



- All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.
 - Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1 [General Design Principles] of the London Borough of Camden Replacement Unitary Development Plan 2006.
- The development hereby permitted shall be carried out in accordance with the following approved plans: 3995/01; 02; 03; email from Shiraz Riaz of Everest Ltd, dated 30th of March 2009.
 - Reason: For the avoidance of doubt and in the interest of proper planning.
- The windows on the southern flank elevation of the rear extension hereby approved shall be obscure-glazed and fixed shut to a height of 1.70m internally and shall be permanently retained and maintained as such.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy SD6 (Amenity for Occupiers and Neighbours) of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6 (Amenity for occupiers and neighbours), B1 (General design principles) and B3 (Alterations and extensions). For a more detailed understanding of the reasons for the granting of this planning permission, please refer to the officers report.

- Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. No. 020 7974 5613 or by email ppp@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts which cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. You are advised to consult the Council's Building Control Service, Camden Town Hall, Argyle Street WC1H 8EQ, (tel: 020-7974 2363).
