Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1 [General Design Principles] and B7 [Conservation Areas] of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; L-01 P01; L-02 P02; L-03 P03; L04 P02; L-05 P01; L-06 P03; L-07 P03; L-08 P03; L-09 P01; L-10 P01.

Reason: For the avoidance of doubt and in the interest of proper planning.

1 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6 (Amenity for occupiers and neighbours), B1 (General design principles), B3 (Alterations and extensions) and B7 (Conservation areas).
