Re: 43 – 45 Fitzjohns Avenue, Swiss Cottage, London.

I visited the above property on Monday 8th February. I inspected trees and reviewed the potential for conflict between the trees and the proposed extension to the rear of the building as shown on Project 195-09 drawing number 1001 dated October 09.

The trees adjacent to the rear elevation of the building are reviewed in the Schedule of Trees appended to this letter report. They are generally young specimens, but one tree, No. 4 a mature Birch, was found to be decayed in the base of the trunk. It is recommended that this tree should be felled for safety irrespective of any proposed development.

The trees being immature and located close to the rear of the building have very low visibility for motorists using Fitzjohns Avenue. Furthermore because of the mass of the building and the closeness of the trees to it, they are unlikely to become visible to the public even in maturity. Pedestrians may just notice the Holly (No. 1) between the site and adjacent property (No. 47). The Birch (No. 4) is visible through the arch in the centre of the building, but this tree is recommended for removal for safety.

The proposed extension at the rear of the building will require removal of all of the trees and the group of Laurels reviewed in the Schedule of Trees. As none of these makes, or is likely to make any real impact on the visual appearance of the district there should be no detrimental effect if they are removed. Trees adjacent to the rear boundary of the site, which would be unaffected by the development, offer a continuing screen between the adjoining group of properties and they should be retained. This can be achieved by construction a temporary fence across the garden between the building and the timber 'summer' house. Such a fence should be anchored to prevent it being moved and maintained throughout any development works.

Post development the character of the rear garden could be improved by some new planting near the boundaries.

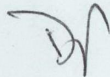

Access to the rear of the building is likely to be along the concreted driveway extending along the side of the property. This appears adequate to accommodate site offices and storage of materials. However, the crown would need lifting to ensure that there is adequate headroom clearance for the delivery and movement of materials.

In conclusion I do not consider that either the quality or the visual amenity offered by the trees should be considered a restraint on the proposed development.
