1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1, B3 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Existing floor plan; Existing finish floor level; Existing RH side elevation; Existing LH side elevation; Existing rear elevation; Proposed finish floor level; Proposed floor plan; Proposed RH side elevation; Proposed rear elevation; Proposed LH side elevation. All dated 24.12.1009 ref 099-63868 A.]

Reason: For the avoidance of doubt and in the interest of proper planning.

- 3 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6 (Amenity for occupiers and neighbours), SD7A (Light pollution), B1 (General design principles), B3 (Alterations and extensions) and B7 (Conservation areas).
