TREE WORK APPLICATION

WORK PROPOSED

Front(see map)

Sycamore

(*Acer pseudoplatanus*)

Self sown sapling growing in the corner of the boundary wall. Suggest: fell to ground level and treat stump to prevent re-growth.

2 Norway Maple

(*Acer platanoides*)

This tree has a ganoderma bracket at root flare, there is also a lot of storm damage within the crown. Suggest: fell to ground level.
Grind down stump to approx. 200mm below ground level

Front

3 Holly

(*Ilex aquifolium*)

This tree is lifting the corner of the footpath. Suggest: fell to ground level and treat stump to prevent re-growth.

Front

G1 Cypress

Group of Cypress trees growing down the boundary line of the house. They are now getting too tall and too close to the property. Suggest: Reduce down to the height of the top of the top floor window along entire group of trees. Trim face to contain and to start forming into a hedge.

4 Ash

(*Fraxinus excelsior*)

Self sown ash sapling, leaning into the footpath and damaging the fence. Suggest fell to ground level and poison stump.

5 oak

TRO 18 H

General maintenance schedule, clean out crown and remove deadwood, weak, suppressed and crossing branches and epicormic growth. Lift over street light.

6 Bay

(*Laurus nobilis*)

This tree is growing through the oak tree, causing damage to the oak. Suggest: reduce in height to clear the oak tree and shape to balance.

7 Bay

(*Laurus nobilis*)

To contain this tree and retard root growth suggest: reduce and re-shape crown by 30%.

8 Cypress

Reduce in height to top of second floor window behind the tree.

9 Cypress

Reduce in height to top of second floor window behind the tree.

10 Beech

(Fagus sylvatica)

This tree has a large fire wound which is very decayed. Suggest: fell to ground level by sectional take down.

Timber removal from site to waste transfer station.

Grind stump to approximately 200mm below ground.

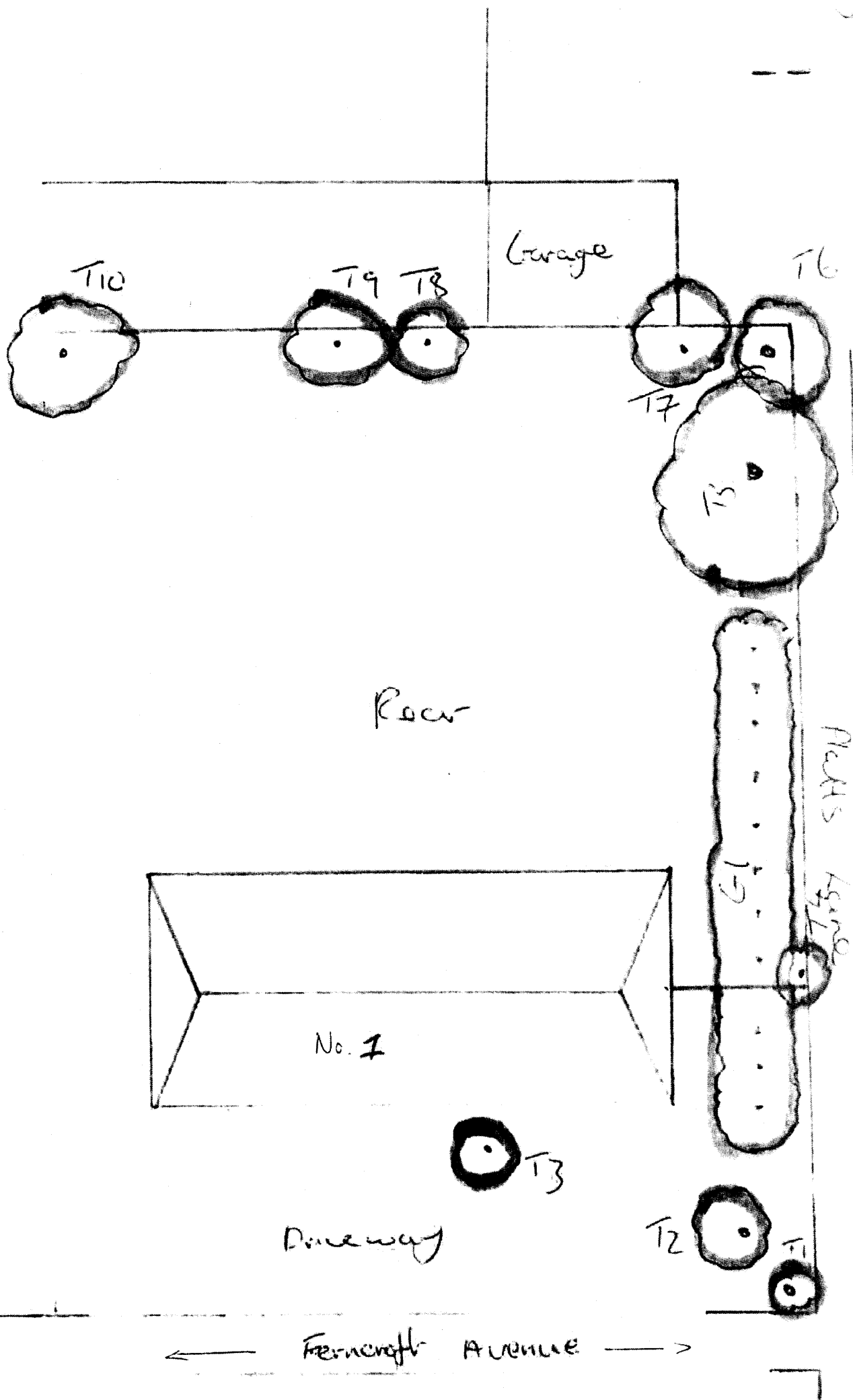
