2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies B1, B3 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: Site Location Plan; AK07; BK07; Section A:A; Section B:B; MP1; and MP2 (dated 11/10/09).

Reason: For the avoidance of doubt and in the interest of proper planning.

1 Reasons for granting permission.

No. 020 7974 5613 or by email ppp@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
