# Condition(s) and Reason(s):

The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).



- All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.
  - Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy B1 [general design) of the London Borough of Camden Replacement Unitary Development Plan 2006.
- 3 The window in the flank wall of the east elevation at second floor level hereby approved shall be obscure glazed and fixed shut and shall be permanently retained and maintained thereafter.

Reason: In order to prevent unreasonable overlooking of neighbouring premises in accordance with the requirements of policy SD6 (amenity) of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission. [Delegated]

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with particular regard to policies SD6 (amenity), H1 (new housing), H7 (lifetime homes), H8 (size mix), B1 (general design), B3 (extensions) and T9 (impact of parking). For a more detailed understanding of the reasons for the granting of this planning permission, please refer to the officer's report.

No. 020 7974 5613 or by email ppp@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
