In addition, the ground floor street entrance would be altered and refurbished to comply with current regulations and provide a more secure level entry. The proposed development retains the existing basement and ground floor whilst refurbishing the first floor flat and converting the second floor flat into two new flats. The existing loft space would be converted into a flat by constructing a new mansard roof. The ridge height broadly remains as existing. This minimizes the impact on views from street level.
