THE EXISTING HEAVY BRICKWORK WALL THAT DIVIDED ROOMS 301 AND 302 ON THE THIRD FLOOR AT 24 RUSSELL SQUARE HAD BEEN CAUSING DEFLECTION TO TIMBER FLOOR STRUCTURE ON WHICH THE WALL WAS LOCATED. AFTER AN INVESTIGATION IT WAS FOUND THAT THE BRICK PARTITION WALL HAD NO SUPPORT FROM BELOW AND WAS CAUSING THE FLOOR STRUCTURE TO BE OVERLOADED. THE HEAVY BLOCKWORK WALL WAS CAREFULLY REMOVED AND REPLACED WITH A NEW LIGHTWEIGHT METAL STUD PARTITION. THE ORIGINAL DOORS HAVE BEEN RETAINED AND THE WALLS HAVE BEEN FINISHED TO MATCH THE PREVIOUS FINISH.
