1 Lime (<i>Tilia spp</i>)	To maintain shape and form. Suggest: reduce back to previous of reduction, clean out crown and remove deadwood.
<u>Front (see map)</u>	
2 Mimosa (<i>Acacia dealbata</i>)	Small undersized tree. It is growing directly underneath T3 and suppressed. Suggest: Fell to ground level and grind down stump to approx. 200mm below ground
<u>Front (see map)</u>	
3 Sycamore (<i>Acer pseudoplatanus</i>)	To maintain shape and form. Suggest: Reduce back to previous points of reduction, clean out crown and remove deadwood. Remove x4 of the lowest limbs to improve the vehicle passage.
<u>Front (see map)</u>	
4 Laurel (<i>Prunus spp</i>)	To maintain shape and form. Suggest: Fell to ground level, right hand stem (leaning away from the building).
<u>Front (see map)</u>	
5 Lime (<i>Tilia spp</i>)	To maintain shape and form. Suggest: Reduce back to previous points of reduction, clean out crown and remove deadwood.



