47 Eaton Avenue

Rear left side

1 Ash (*Fraxinus excelsior*)

Self seeded vigorous tree, trunk expansion has pushed over the boundary wall. Suggest: Fell to ground level by sectional takedown to allow wall to be rebuilt.

Cut up and remove timber from site.

Option: Grind down stump.

Rear of house in private garden section.

3 False Acacia (*Robinia pseudoacacia*)

Very large mature twin stemmed tree. Fungal brackets present in main fork at 2m height, presuppose some degree of internal decay and structural weakness. Potential hazard tree re failure.

Suggest: Fell to ground level by sectional takedown.

Cut up and remove timber from site.

Option: grind down stump.

Adjacent rear left corner of house & side elevation

4 Sycamore x 3

(*Acer
pseudoplatanus*)

Self seeded medium mature very tall and etilated trees growing in between & very close to properties. Cannot be left in situ. Will cause problems if left any longer. Suggest: Fell all 3 trees to ground level by sectional takedown.

Cut up and remove timber from site.

Option: Grind down stump.

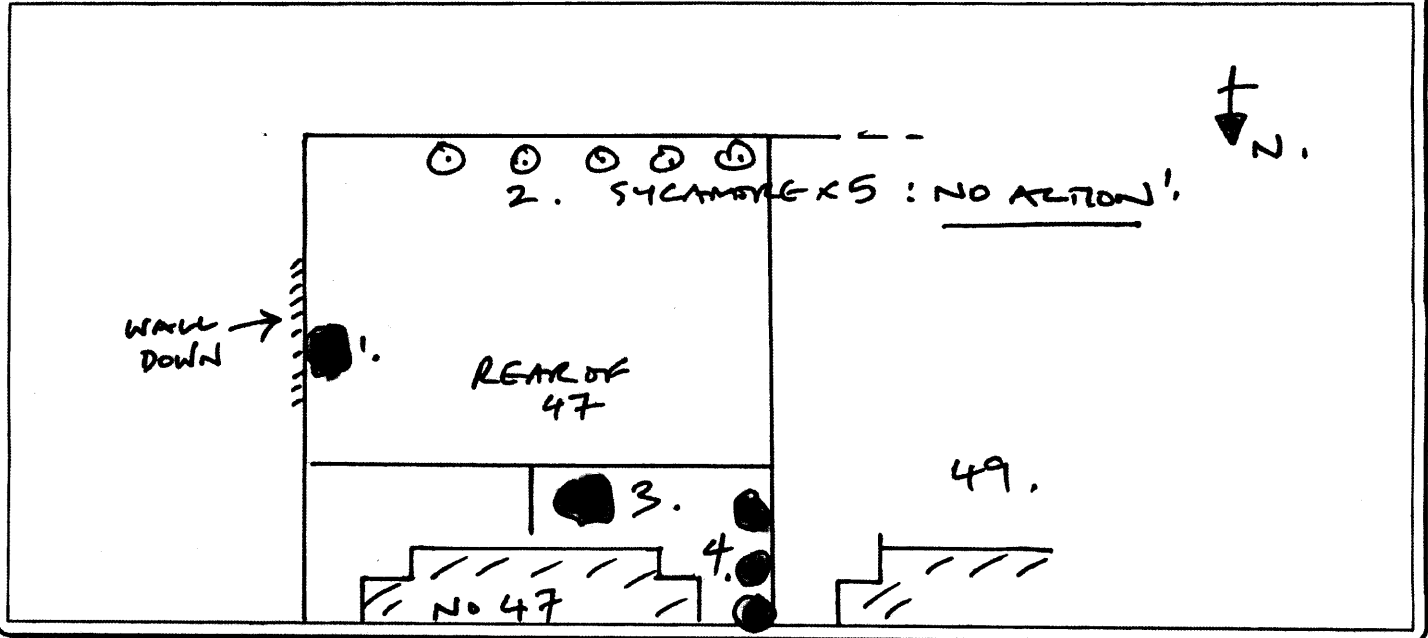
