- Chimney to be made good, re-rendered where required and painted.
- Chimney pots to be replaced if missing builder to assess.
- All windows at second floor level to be replaced.
- Existing SVP to have new wire cage or other perforated cover, as none exists at the moment.
- Builder to Assess all dormer and chimney cheeks.
- All gutters and downpipes to be replaced.
- Fascias to be rubbed down and painted.
- Once tiles have been stripped off, insulation to be installed inbetween rafters, and membrane to be installed, please refer to section AA.
- All lead flashing to be replaced, to be installed in accordance with the lead association handbook.

- * Window to Habitable rooms to have an unobstructed openable area of at least 0.33m² and at least 450mm high and 450mm wide. Builder to check window sizes on site visit. Proposed windows to be doubled glazed with timber frames and trickle vents.
- All existing first floor windows to be eased by contractor and allow for installation of missing catches.
- Full external redecc, all existing render, brickwork to be re-painted colour to be confirmed.
- All existing guttering and downpipes to be stripped off and new ogee 6" black guttering to be installed with new brackets.
- Main contractor to allow £200.00 PC sum for jet washing drains.
