<u>Rear Boundary Line</u>	
1 Sycamore x 5 (<i>Acer pseudoplatanus</i>)	Self sown trees growing along the boundary wall causing it to collapse in the last six weeks. During the rebuilding of the wall several large anchoring roots were severed to allow rebuild, they are now potentially unstable. These trees are of poor quality and have suffered from previous poor pruning resulting in structural defects. I strongly suggest fell to ground level. And grind down stumps
<u>Rear Boundary Line</u>	
2 Black Poplar (<i>Populus nigra</i>)	Self sown trees growing along the boundary wall causing it to collapse in the last six weeks. During the rebuilding of the wall several large anchoring roots were severed to allow rebuild, they are now potentially unstable. These trees are of poor quality and have suffered from previous poor pruning resulting in structural defects. Suggest fell to ground level. And grind down stump



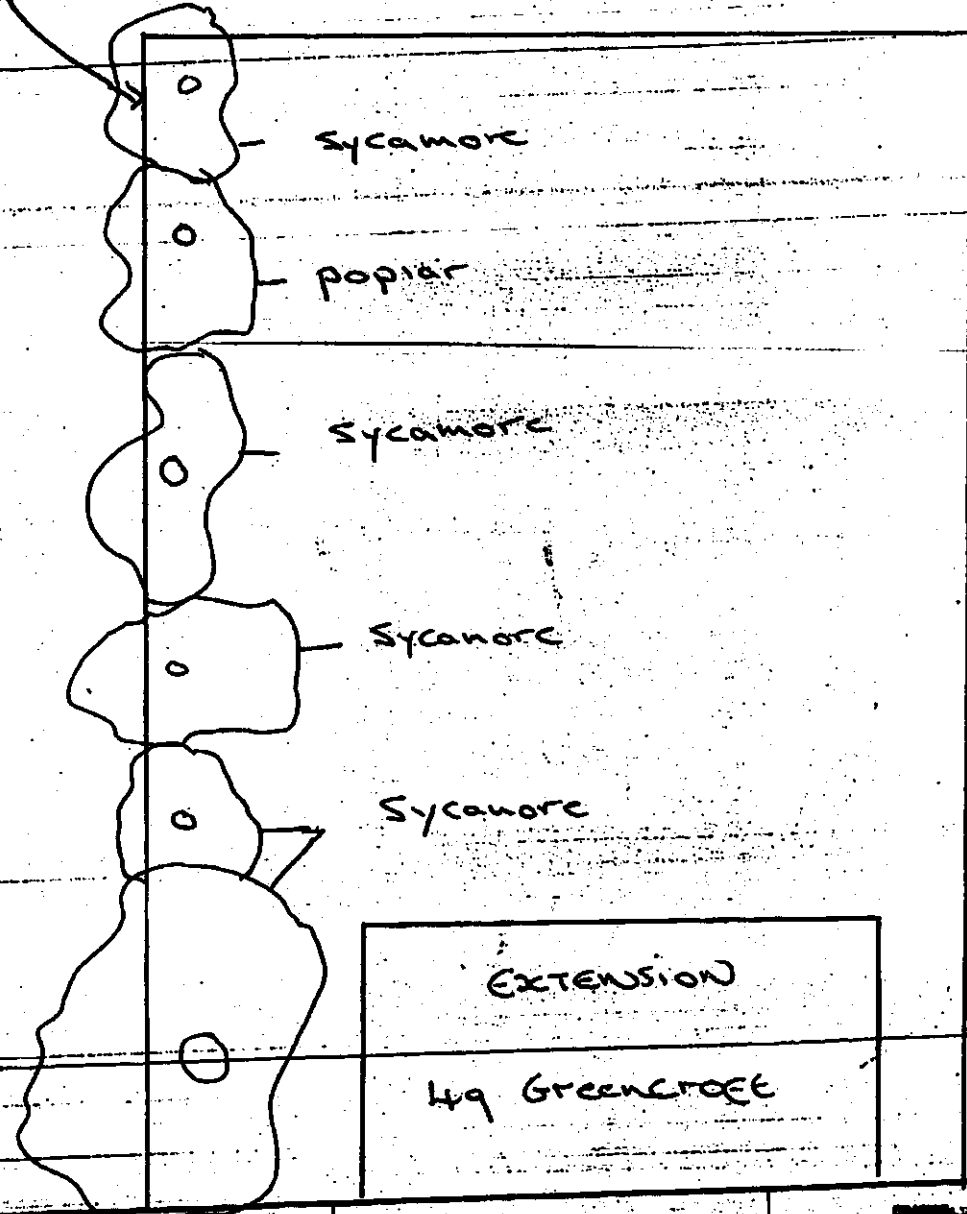
