Most applications require more information than can be provided by the application form alone.

The local planning authority will not be able to process your application unless the mandatory supporting documentation has been provided. You can also attach any other relevant documentation which you think will help the local authority determine the application.

Planning Application Requirements & Local Level Requirements

There are two levels of requirements, national and local:

National - This is detailed in the 'Mandatory documentation' section below.

Local - The local planning authority will have produced a document (usually available from a link in the right-hand side panel below) which details any specific information that is required to accompany the application in addition to the national requirements.

For further details of the mandatory documents please refer to the CLG guidance note <u>'The Validation of Planning Applications: Guidance for local planning authorities'</u>.

When uploading supporting documents for electronic submission individual files should not exceed 5MB in size. There is currently no limit on the overall size of all attachments however we do recommend that you do not exceed 25MB as some LPAs may have restrictions on their own sites.

You need to provide information in support of your application. Failure to do so may result in your application being rejected or delayed

Mandatory documentation

You must provide the following documents for your application to be valid.

Use the 'Add document' link to enter document details and either attach the document or confirm that you will supply it by post.
