No. 020 7974 2090 or by email env.health@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
- You are advised that all the conditions attached to planning permission 2007/5935/P granted on 26/02/2008 are still applicable to this consent. The drawings submitted with this application are however considered sufficient to discharge the requirements of condition 2 of planning permission 2007/5735/P which required the details of the sections, elevations and facing materials of the new windows and dormer to be used on the building shall not be otherwise than as those submitted to and approved by the Council before any work is commenced on the relevant part of the development. The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved.
