Installation on carriageway of a cycle hire docking station including a registration/payment terminal and maximum of 22 docking points for bicycles, in connection with the Transport for London Cycle Hire Scheme.

The development hereby permitted must be begun not later than the end of three years from the date of this permission.



Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All external metal components of the Cycle Hire Station hereby shall consist of '316' grade stainless steel with a shot-peened 'A16' finish on visible surfaces unless otherwise approved in writing for the Local Planning Authority.

Reason: To safeguard the character of the immediate area in accordance with the requirements of policies B1 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

All surface materials should match the existing adjacent materials unless otherwise approved in writing by the Local Planning Authority.

Reason: To safeguard the character of the immediate area in accordance with the requirements of policies B1 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.

4 All trees on the site, unless shown on the permitted drawings as being removed, shall be retained and protected from damage in accordance with the Tree Survey Report dated 04 May 2009 hereby approved.

Reason: To ensure that the Council may be satisfied that the development will not have an adverse effect on existing trees and in order to maintain the character and amenities of the area in accordance with the requirements of policies N8 of the London Borough of Camden Replacement Unitary Development Plan 2006.

1 Reasons for granting permission.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with regard to policies SD1, SD6, SD7, B1, B3, B7, T1, T3, T7, T9, T12, N8 and in general accordance with the requirements of the London Plan 2004, with particular regard to policies 2A.1, 3C.A, 3C.3, 3C.9, 3C.17, 3C.18, 3C.22, BB.1, 4B.5. You are strongly encouraged to take on board the issues set out in the letter 'Details for further discussion' prior to the implementation of the scheme.

4 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays.
