Proposal:

Installation on footway of 2 cycle hire docking stations including a registration/payment terminal and maximum of 18 docking points for bicycles, in connection with the Transport for London Cycle Hire Scheme.

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All external metal components of the Cycle Hire Station hereby approved shall consist of '316' grade stainless steel with a shot-peened 'A16' finish on visible surfaces unless otherwise approved in writing for the Local Planning Authority.

Reason: To safeguard the character of the immediate area in accordance with the requirements of policy B1 of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 All trees on the site, unless shown on the permitted drawings as being removed, shall be retained and protected from damage in accordance with the Tree Survey Report dated 07 May 2009 hereby approved.

Reason: To ensure that the Council may be satisfied that the development will not have an adverse effect on existing trees and in order to maintain the character and amenities of the area in accordance with the requirements of policies N8 of the London Borough of Camden Replacement Unitary Development Plan 2006.

4 All surface materials within the cycle hire docking station (except for the perimeter) should match the existing adjacent surface materials unless otherwise approved in writing by the Local Planning Authority.

Reason: To safeguard the character of the immediate area in accordance with the requirements of policies B1 of the London Borough of Camden Replacement Unitary Development Plan 2006.

5 No development shall take place until the detailed treatment of the highway surface on the perimeter of the cycle hire docking station (including dimensions, layout, and materials) has been submitted to and approved in writing by the local planning authority. The treatment shall incorporate a surface material of contrasting texture to define the perimeter of the docking station. It shall be carried out in accordance with the detail thus approved and shall thereafter be permanently retained and maintained.

Reason: To ensure safe and convenient pedestrian routes, and to prioritise the pedestrian safety for vulnerable users in accordance with the requirements of policy T3 of the London Borough of Camden Replacement Unitary Development Plan 2006.

The proposed development is in general accordance with the policy requirements of the London Borough of Camden Replacement Unitary Development Plan 2006, with regard to policies, SD1, SD6, SD7, B1, B3, B6, T1, T3, T7, T9, T12 and in

- 4 Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must carry out any building works that can be heard at the boundary of the site only between 08.00 and 18.00 hours Monday to Friday and 08.00 to 13.00 on Saturday and not at all on Sundays and Public Holidays. You are advised to consult the Council's Environmental Health Service, Camden Town Hall, Argyle Street, WC1H 8EQ (Tel. No. 020 7974 2090 or by email env.health@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
