Please could I follow up with you an outstanding matter from last year relating to a tree which the University through Connick Tree Care had sought permission to remove, as we were concerned about safety and branches falling.

Please could you take a look at this tree T0640, (Weeping Wych Elm, located within Torrington Square opposite Birkbeck College building), which we believe is dead – it does not have any foliage at all . If it is dead, and it is therefore not now necessary to carry out the tests proposed, may we proceed with removal?

Dear Mr. Rainsbury,

Thank-you for your time yesterday morning. Further to our meeting I have outlined below the works the Council consider unnecessary. If a revised schedule is submitted to the Council by the 19/12/2008 omitting all the following works we can provide a decision notice based on the amendments as soon as possible.

- T0607-T0617 (x10 London Planes, Side of Senate House fronting Malet Street) Secondary Pollard at approximately 14 metres above ground level. It is considered that these trees are not in need of any current works.
- T0640 (Weeping Wych Elm, located within Torrington Square opposite Birkbeck College building) advised removal. The Council need to inspect the tree when it is in leaf next year to assess the level of decline. It is also recommended that decay detection test (resistograph or picus) are carried out to the Elm and a root inspection (hand dug) is carried out to further assess the trees decay potential and structural stability.
- T0704, T0705, T0707-T0712, T0714, T0716, T0720 and T0722 (x12 Lime trees, along front of Malet Street Gardens opposite the side of Senate House) Secondary pollard at approximately 12 metres above ground level (T0710, secondary pollard at approximately 8 metres above ground level). It is considered that these trees are not in need of pollarding. Removal of epicormic growth and basal suckers is considered acceptable.

Please remove the above works and relevant trees from the schedules and submit them to the Council so the application can be dealt with as quickly as possible. If you have any further queries do not hesitate to contact me on the below details.
