- All external metal components of the Cycle Hire Station hereby approved shall consist of '316' grade stainless steel with a shot-peened 'A16' finish on visible surfaces unless otherwise approved in writing for the Local Planning Authority.
 - Reason: To Safeguard the character the immediate area in accordance with the requirements of policies B1 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.
- All surface materials should match the existing adjacent surface materials unless otherwise approved in writing by the Local Planning Authority.
