CA Yew tree: Lift to 2½ metres for light and access, Remove ivy from adjacent maintain Ash.


④ Further work planned in the wood involve leveling the ivy at base of 7 Sycamores & 2 Limes.

Also removal of dead wood from one large oak - 2 branches,

+ 2 Sycamores and 1 sweet chestnut

all of which I presume no formal sanction applies.


