Change of use and works of conversion from 5 residential units to 4 residential units, erection of two dormers on rear roof slope, creation of a roof rear roof terrace with associated balustrading on top of two storey rear addition, and new timber door at first floor level.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies S1, S2, B1, B3 and B7 of the London Borough of Camden Replacement Unitary Development Plan 2006.
