2 All new work and work of making good shall be carried out to match the original work as closely as possible in materials and detailed execution.

3 The works hereby approved are only those specifically indicated on the drawing(s) referred to above.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.

- 4 Detailed drawings, or samples of materials as appropriate, in respect of the following, shall be submitted to and approved in writing by the Council before the relevant part of the work is begun:
  - a) Section drawings at a scale of no less than 1:5 or samples of all new cornicing including corresponding location plans
  - b) Section drawings at a scale of no less than 1:2 or samples of all new skirting including corresponding location plans
  - c) Location of all rehung doors including corresponding photographs of the doors
  - d) Plan, elevation and section drawings or sample of all new ceiling roses with corresponding location plan

The relevant part of the works shall then be carried in accordance with the approved details

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.

A method statement or large sample area of the new lath and plaster walls and ceilings, including details of removal of the cement to the basement walls shall be submitted to and approved in writing by the Council before works are commenced. The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy B6 of the London Borough of Camden Replacement Unitary Development Plan 2006.
