Reasons for Refusal

The Council has not been able to determine the impact of the window detail on the appearance of the building due to the failure to provide a window sample as required by condition 2 of planning approval 2005/1421 dated 3rd. January 2007. Details may have an adverse impact on the appearance of the building contrary to policy B1 (general design principles) of the London Borough of Camden Unitary Development Plan 2006.

Informative(s):

- You are advised that condition 2 cannot be fully discharged because information submitted concerning windows is insufficient. Information is conflicting and a window sample has not been provided. You are reminded that work on the relevant parts of the building should not progress prior to written approval by the Council of facing materials.
- 2 I would advise you that you are in breach of condition 2 as window details should have been submitted before work commenced. You have not submitted window samples therefore part of condition 2 has not been discharged. This renders your entire scheme unlawful.
- 3 You are advised to submit an application for planning permission to regularise works that do not strictly comply with approved drawings including the shop front and alterations to fenestration.
