### NOTIFICATION OF PROPOSED WORK IN SWISS COTTAGE CONSERVATION AREA

- To partially reduce the crown of the tree marked P2 on the sketch map, while maintaining the pleasing shape of the canopy shared with the neighbouring tree (also an *Acer x hispanica*) marked P1 on the sketch map, by reducing the top height by about 3m and reducing the laterals by about 5m to the north, east and south.

### REASON FOR THE PROPOSED WORK

- To cut back growth overhanging the garden of No. 67 Priory Road and the rear of 6-8 Alcol Road without spoiling the visual amenity of the canopy shared with tree P1
