- 01 To safequard the appearance of the proposed premises and the character the immediate area.
- 02 To safeguard the visual amenities of the area and to prevent over-development of the site by controlling proposed extensions and alterations.

Ol You are reminded that the details of the proposed landscaping scheme for the residential sites including both paying and soft landscaping; also, the proposed lighting arrangements for both sites have yet to be agreed by the Council.
