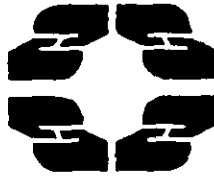

- 01 The limited period for the retention of the building and the continuation of use shall be until 31.03.85 by which date the building shall be removed and the use discontinued and determined.
- 02 The operation of the use shall be limited to the hours of 7a.m. to 6p.m. on Mondays to Fridays, 7a.m. to 1p.m. on Saturdays and no operation on Sundays and Public Holidays.
- 03 (a) No wastes other than solid non-putrescible wastes as detailed below shall be received or handled at the facility:

(c) No clinical waste as defined in Clause 4 of the document entitled "The Safe Disposal of Clinical Waste" issued by the Health and Safety Commission and the Health Services Advisory Committee in May 1982 shall be handled at the site.

04 No burning of waste shall take place on the site.

01 The use as a waste transfer station is not such as the Council would be prepared to approve other than for a limited period and would prejudice the proper development of the site.
