Reasons for refusal In the Council's experience the establishment of social clubs in residential areas is undesirable, and there is considerable adverse effect on the amenities of such areas not only by reason of noise from within the building (in the present case it is proposed to provide music by a piano and occasional trio), but also by reason of noise occasioned when members leave the club, from the closing of motorcar doors, motorcar enquiries, etc. It is also the Council's experience that in the absence of any car-parking

arrangements the members' cars are parked in the roadway causing obstruction of access to nearby properties.
