

1. The development hereby permitted must be begun not later than the expiration of five years from the date on which this permission is granted.


Reason for Standard Condition:

1. In order to comply with the provisions of Section 41 of the Town and Country Planning Act 1971.

Additional Condition(s):

- Ol The limited period for the use shall be until 1st July 1988 by which date the use shall be discontinued and determined.
- 02 The two pairs of entrance gates shall be renewed and the existing steel gantry removed before the use of the site commences.
- 03 The use hereby permitted shall not be carried out otherwise than between the hours of 8.00am and 6.00pm on Mondays to Fridays, and 8.00am and 1.00pm on Saturdays, and at no time on Sundays.
- 04 The site shall be used only for storage and sale of new and used building materials and for no other purpose, (including any other purpose within Classes I and X of the Schedule of the Town and Country Planning
