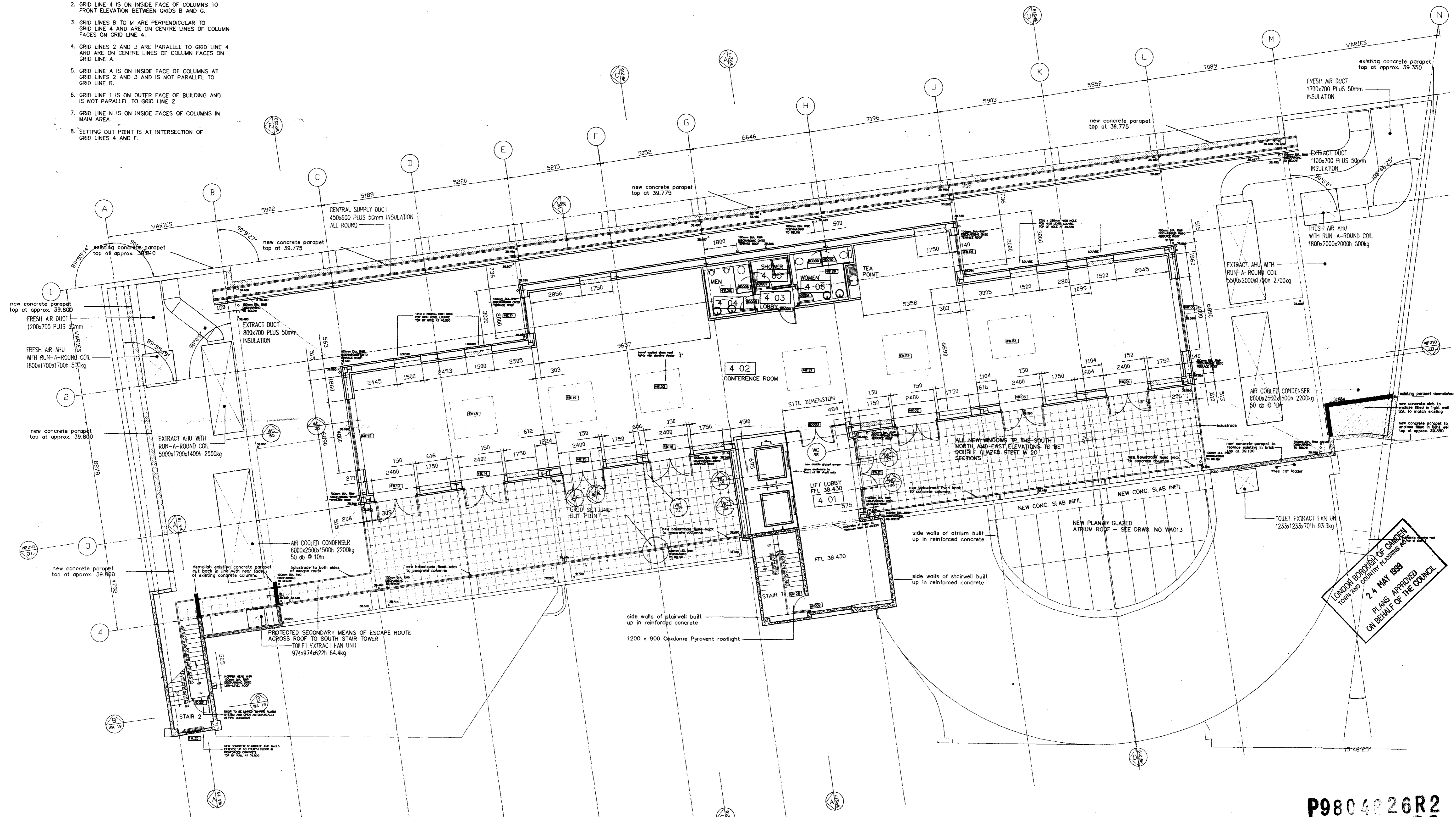

GRID SETTING-OUT CRITERIA IS AS FOLLOWS :-

1. ALL DATA REFERRED TO IS TAKEN AT THIRD FLOOR LEVEL.
2. GRID LINE 4 IS ON INSIDE FACE OF COLUMNS TO FRONT ELEVATION BETWEEN GRIDS B AND C.
3. GRID LINES B TO M ARE PERPENDICULAR TO GRID LINE 4 AND ARE ON CENTRE LINES OF COLUMN FACES ON GRID LINE 4.
4. GRID LINES 2 AND 3 ARE PARALLEL TO GRID LINE 4 AND ARE ON CENTRE LINES OF COLUMN FACES ON GRID LINE A.
5. GRID LINE A IS ON INSIDE FACE OF COLUMNS AT GRID LINES 2 AND 3 AND IS NOT PARALLEL TO GRID LINE B.
6. GRID LINE 1 IS ON OUTER FACE OF BUILDING AND IS NOT PARALLEL TO GRID LINE 2.
7. GRID LINE N IS ON INSIDE FACES OF COLUMNS IN MAIN AREA.
8. SETTING OUT POINT IS AT INTERSECTION OF GRID LINES 4 AND F.
