Reason(s) for Additional Condition(s):

01 To ensure that the Council may be satisfied with the external appearance of the building.

Informative(s):

- 01 Your attention is drawn to the requirements of Sections 4, 7, and 8A of the Chronically Sick and Disabled Persons Act 1970 that this building (for employment use or to which the public will be admitted) should be made accessible to disabled people wherever practicable. Guidance is provided in British Standards Institution Code of Practice BS 5588 1987 "Access for the Disabled to Buildings".
- O2 Works of construction and ancillary activity should not take place other than between the hours of 8am to 6pm on Monday to Friday and 8am to 1pm on Saturday, with no working on Sunday or Bank Holidays, in order to comply with locally enforced standards.
- 03 At all times the best practical means are to be employed to keep noise at an absolute minimum. This encompasses the selection of fully silenced power tools and generators and the use of acoustic screens and enclosures where necessary.
- O4 The contractors should supply a work method statement to be agreed by the Council before any works commence. This statement should detail each phase of the works of the plant to be used and location and any out of normal hours working that could cause disturbance such as the import of special plant.
