

- 01 The limited period for the retention of the buildings and the continuation of the use shall be until until 1 Dec. 2000 by which date the building shall be removed and the use discontinued and determined.
- 02 Notwithstanding the provisions of Article 3 of the Town and Country Planning General Development Order 1988 (as amended) or any Order revoking and re-enacting that Order, no development within Part 1 (Classes A to H) and Part 2 (Classes A to C) of Schedule 2 of that Order shall be carried out without the grant of planning permission having first been obtained from the Council.

Reason(s) for Additional Condition(s):

- 01 The type of building is not such as the Council is prepared to approve, other than for a limited period, in view of its appearance.
- 02 To safeguard the visual amenities of the area and to prevent over-development of the site by controlling proposed extensions and alterations.
