



Further to our telephone conversation on Friday, 25<sup>th</sup> July 1997, we enclosed 1 no. copy of our joinery manufacturer's drawing nos. PP/10236/01, 02, and 03, as discussed. These should be read in conjunction with our elevation drawing nos. 1201/SK64, SK65, and SK66, 1 no. copy of each is also enclosed.

As you can see from the drawings we are utilising wherever possible standard sash sections which are entirely in keeping with the style and age of the existing building. Where the constraints of the existing structure dictate otherwise casement windows are proposed and these are primarily on the existing 6<sup>th</sup> floor mansard and the arch shaped apertures on the 3<sup>rd</sup> floor.

Details of the French doors in the new roof construction are still being worked up and will be issued to you for your consideration when complete, as will the ground floor entrance doors around the base of the corner turret.

The specification and finish of the new windows will be double glazed window units in a softwood frame and hardwood cill with either a paint or dark seal finish. Trickle vents will have to be incorporated within the frame of each window to comply with Building Regulations and your guidance on their position as well as finish of the window frame as a whole will be sought in due course.


