SCHEDULE (continuation)

- 01 Any advertisements displayed, and any site used for the display of advertisements, shall be maintained in a clean and tidy condition to the reasonable satisfaction of the Common Council.
- 02 Any structure or hoarding erected or used principally for the purpose of displaying advertisements, shall be maintained in a safe condition.
- 03 Where an advertisement is required under these Regulations to be removed, the removal thereof shall be carried out to the reasonable satisfaction of the Common Council.
- 04 No advertisement is to be displayed without the permission of the owner of the site or any other person with an interest in the site entitled to grant permission.
- 05 No advertisement shall be sited or displayed so as to obscure, or hinder the ready interpretation of, any road traffic sign, railway signal or aid to navigation by water or air, or so as otherwise to render hazardous the use of any highway, railway, waterway (including any coastal waters) or aerodrome (civil or military).
- 06 Period of consent from:- 25.08.89 until 24.08.94 REASON (conditions 1-6): To ensure compliance with the Town and Country Planning (Control of Advertisements) Regulations, 1989.
