Bloomsbury CAAC

This seems a wholly inappropriate concept for the front of the British Museum, which is one of few truly monumental and dignified buildings in London. We are bemused by the positive reporting of the African Garden, which in practice was badly maintained with tropical plant shrivelling up in the hot summer sun. The lawn itself should be given proper maintenance and left at that. The occasion of the Beijing Olympics does not need to be recorded here – local residents are already feeling apprehensive about the effect on the area of the London Olympics.

CAAC comments:

Officer comment: The garden would be retained for a temporary period only. It would be similar to the African Garden created in 2005. The applicant has submitted details of the proposed landscaping and also the manner in which the lawn would be restored following the removal of plants and landscaped areas. The applicant has also described how the plants would be transplanted to a local public square.

English Heritage

Specialist staff have considered the information received, and do not wish to offer any comments.

Site Description

The British Museum is a Grade 1 listed building bounded to the north by Montague Place, to the east by Montague Street, to the west by Bloomsbury Street and to the south by Great Russell Street. There are large rectangular shaped lawns on either side of the main entrance into the Museum. Located within the Bloomsbury Conservation Area.

Relevant History

PP granted for the formation of an African Garden, including screens, timber path and planting to the existing lawn for a temporary period between 28th April 2005 and 30th September 2005, subject to a condition limiting the retention of the works to the temporary period only, and requiring that the lawn be reinstated in accordance with details to be approved, by 30th September 2005.

Assessment

<u>Proposed</u> is a Chinese landscaped area as a temporary installation (May – December 2008). The proposal follows discussions and collaboration with the Royal Botanic Gardens Kew and Camden Parks and Open Spaces Team.

Entering through the main Museum gates, the area that would be planted is the left. Plants would be of various heights ranging from ground shrubs to a 5m high Dawn Redwood. Also proposed is a bamboo trellis 6m x 4m x 3m. It would be secured with screws and ropes, and would cover part of the path that would created through the planted area. The project would include sculptures.

Access

The path would be 2m wide, enough for a wheelchair, and would rise up to a maximum height of 1m. However, the gradient proposed would enable wheelchair uses to travel along the path safely, and at the top of the ramp there would be flat area to enable wheelchair users to rest. The landscape would be multi-sensory (touch, taste, listen) for the inclusion of visually impaired and deaf people.

<u>Following the removal</u> of the Chinese landscape, the plants would be transplanted in one of the local public open spaces, possibly Tavistock Square. The period for the display has been extended to December 2008, as the plants would then be dormant and this would maximise their chance of survival when transplanted (this was suggested by Kew). The lawn would be re-instated; if approved a condition is recommended that requires details of the lawn re-instatement to be submitted for the Council's approval; as was a requirement of the approval of the Africa Garden.

The small trellis proposed would be installed to the west of the landscaped area and would not restrict views of the planting from the entrance.

The proposed works are relatively modest and, given that they would only be in place for a temporary period of approximately five months, it is considered that they would not have a significantly detrimental impact on the setting of the listed building or on the character and appearance of the

conservation area. There would be no detrimental impact on the amenities of adjoining occupiers.

The trellis and landscaping are proposed for a temporary period to coincide with events related to the Beijing Olympic Games. The landscaping is mostly at a low level and will have a limited impact on the setting of the listed building and the character and appearance of the Bloomsbury Conservation Area. The trellis will be visible against the lower portion of the building, but its open nature will ensure that is not a dominant feature in the forecourt, and will not disrupt the building's historic setting.

As the proposal is a temporary feature designed to coincide with an international event, it is considered acceptable for this short time. No historic fabric will be affected.
