October 2007, ref. EN07/0630. It is my understanding that Mr. Osborne and Ms. Hayward were unaware of the need to apply for planning consent.

2. DESIGN BRIEF AND ACCESS STATEMENT:

- 2.1 The garden shed is located in the Northeast corner of the garden at 10 Prince Arthur Road within the exclusively residential area of the Fitzjohn's and Netherall Conservation Area in Hampstead Village. The detached two-storey + attic house is Victorian without any listed status.
- 2.2 The total cubic volume of the shed is approximately 22m3 + 10.5m3 (porch) = 32.5m3.
- 2.3 The shed is constructed of a lightweight timber frame with a traditional appearance that includes ship-lap siding, 4 traditional fixed timber windows, small porch and pitched roof with asphalt shingles.

- 2.4 The owners have constructed this shed for multiple purposes which includes the following: outdoor play area for their 4 young children (ages 11, 9, 7 and 4), small study/ reading area for Mr. Osborne who is a writer. Mr. Osborne uses this shed as a retreat in order to gain silence and concentration in what is often a very active house. Mr. Osborne does not have an office and works out of his home in order to help care for his children.
- 2.5 After a number of visits to study the affect of light it is apparent that the shed does not significantly alter the current light levels to the terrace at 7/8 Prince Arthur Mews. (Please see plan A102, noting the angle of incidence in reference to the existing brick wall and shed construction.
- 2.6 Please note the shaded area produced by the existing brick wall in diagram A102. It should be noted that the full window height lies within this area. The shed therefore has no bearing on the amount of sun entering the room. This is made particularly true by the shed's narrow width.
- 2.7 The introduction of the shed does not affect any byways or highways.
