Site Description

King's Cross Station, Euston Road

Relevant History

2006/3394/L Listed Building Consent for : Alterations, extensions, refurbishment works to King's Cross Station including construction of the Western Concourse to abut the Western Range and the Great Northern Hotel. Granted 09/11/07

Assessment

Condition 3 Consent 2006/3394/L granted 09/11/07 states the following:-

"No works authorised by this consent shall take place until the applicant has implemented a

programme of building recording and analysis by a person or body approved by the Council as local

planning authority. This programme shall be in accordance with a written scheme which has been

submitted by the applicant and approved by the local planning authority advised by English Heritage".

The purpose of the Building Recording is the compilation of a lasting record of the site and building prior to the alterations, extensions and refurbishment works to the Western Range and the creation of

the Western Concourse.

The submitted document presents the written scheme for Building Recording, commissioned by Network Rail as partial requirement of condition 3 (2006/3394/L). The document outlines the aims and objectives for the recording work as well as standards for the presentation of findings and requirements for a watching brief. The document confirms that the level of recording will be "Level 2", as detailed in English Heritage's "Understanding Historic Buildings, A Guide to Good Recording practice, 2006".

This written statement was used as the basis for informing contractors invited to tender for the recording work. Ingram Consultancy, Historic Building Consultants, who are currently working on the

refurbishment work to the Eastern Range of King's Cross Station, have been, after discussion with English Heritage, selected as the Building Recording Contractor. Details of the practice are included in the submitted documents. Prior to the commencement of Building Recording, Ingram Consultancy, are required to supply a Method Statement to the LPA. The Method Statement shall be in accordance with this submitted written scheme. Building Recording will be carried out in advance of and during the early stages of the work that is to be carried out to King's Cross Station. Building Recording Reports will be prepared as follows:- Phase 1 – In advance of works Reports will be prepared to contain comprehensive photographic records of the relevant area within the station, with associated commentary fully describing each of the items/ areas of architectural and/or historic interest with relevant supporting drawings. The Phase 1 reports shall include the results of a desk study to identify any further hidden architectural or historic items of interest likely to be found during the works. Phase 2 - Watching Brief/reports These reports will record findings of regular inspections on site at not greater than fortnightly intervals, during the initial opening up of the works. The reports will record hidden items of architectural and historic interest as they are uncovered. The recording contractor will therefore be required to attend on a periodic basis over an extended period as the work progresses.

On completion of the recording work all the reports will be collated to produce a single master

document. The master document will be of archive quality and it is proposed that it will be deposited,

in agreement with English Heritage and LB Camden, with the NMR or another appropriate body.

The details submitted with regard to the requirements of the first part of Condition 3 are thought to be sufficient. As detailed above further submissions will be needed in due course.
