Assessment

Condition 4 of Consent 2006/0040/L states :-

"Any hidden features which are revealed during the course of the works shall be retained in situ, work suspended in the relevant area of the building and the Council as local planning authority notified immediately. Provision shall be made for their retention and/or proper recording, as required by the Council".

This proposal has been submitted as a proactive measure. Its purposed is to mitigate delays to the on-site construction work caused by suspension of the work in accordance with condition 4 above.

Agreement to this proposal should allow work to continue and previously hidden features recorded, unless the exposed elements are of a very high significance. In such cases the local planning authority will by notified in the usually way.

The proposal includes comprehensive measures to ensure hidden details are retained in situ, recorded and only removed if their removal forms part of the consented work.

The report details the:

Training and Awareness that is to be undertaken to ensure that hidden historic features are dealt with an appropriate way. The measures include:

- Site Induction including a heritage briefing
- Work Package Plans
- Task Briefing

Watching Brief – this is to be undertaken by Graham Abrey, the contractor's Historic Advisor and monitored by Kevin Murphy, Network Rails Heritage Advisor.

Building Recording - It is intended that all further building recording work within the Eastern range will be produced as a document which will be read in conjunction with the existing building record which has been submitted to discharge Condition 3 of the same Listed Building Consent (2006/0040/L).

The submission details the following recording methods :- Written Accounts, Photographic Records, Drawing Records and a Construction Photographic Record.

The completed record will be submitted to the Local Planning Authority when an appropriate archive will be agreed.

GLAAS also commented by letter dated 16th January 2008, that after the completion of the building recording and watching brief that a report is to be compiled on the results. Two copies of the final report will be needed. One to be lodged with GLSMR. In addition an OASIS form is to be provided with the report The archive must also be deposited at the London Archaeological Archive and Research Centre in accordance with the Museum of London guidelines. This can then be undertaken in correspondence with the below-ground archaeological elements of the project.
