

## Planning Permission for Window Replacement – 16 Dennington Park Road (the "Flat")

In April 2006 we bought and moved into our Flat (which is the upper ground floor flat). The Flat is one of three self contained flats in the house. The other two flats are 16A (first and second floor) and 16B Dennington Park Road (lower ground floor). The house is neither a listed building nor situated in a conservation area.

Each of the flats is subject to a leasehold and each leasehold owner owns one share of the freehold company, 16 Dennington Park Road Limited. Notice of the planning application enclosed with this letter was given to the two other leasehold owners and to the freehold company (copies enclosed).

We would like to replace the Flat's windows and one sliding door. I understand from Emma Fenton, the Camden Duty Planner, who I spoke to on 9 October 2007, that we need to apply for planning permission as the house is split into different flats. A planning application form is enclosed with this letter.

## A. Existing Windows and Door

The Flat has three windows to the front of the house and one window and a sliding door facing the back. I enclose photos of the Windows and the sliding door on sheet 1 and 2.

The windows and the sliding door are aluminium framed and approximately 25 years old. They do not match any other windows in the house (see picture 1, sheet 1) which are white (pvc) framed made to look like sash windows at the front and simple white framed windows at the back of the house (see picture 1 on sheet 2).

The existing windows and sliding door are damaged. Some windowpanes have cracks and the frames are broken letting in rain and a constant drought. Some of the Windows have been provisionally sealed and now cannot be opened anymore because they are glued shut. I attach photos of some of the damage to windows and the sliding door on **sheet 3**.

## B. Replacement Windows and Door

Apart from improving our flat's thermal insulation to save energy, we would like the house to regain its original appearance. The house next door on the right hand side, 14 Dennington Park Road ("Number 14"), is identical to ours. However, Number 14 has retained its original features, including the original white wood frame sash windows. I attach a photo on **sheet 4** showing Number 14's front windows.

We are therefore applying for permission to replace the existing windows and the sliding door with energy efficient, white solid wood framed windows which, at the front of the house, will resemble the original sash windows. I enclose drawings and specifications for the replacement windows on sheet 5.
