2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies and B1 and B3 of the London Borough of Camden Replacement Unitary Development Plan 2006.

3 Not withstanding the information shown on drawing 609/13/B the proposed side dormer should be set down from the ridge line by at least 500mm as shown on the elevational drawings.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies and B1 and B3 of the London Borough of Camden Replacement Unitary Development Plan 2006.

No. 020 7974 2090 or by email env.health@camden.gov.uk or on the website www.camden.gov.uk/pollution) or seek prior approval under Section 61 of the Act if you anticipate any difficulty in carrying out construction other than within the hours stated above.
