## **Assessment**

This application seeks to discharge Condition 15 of planning permission 2004/1061/P granted on 30<sup>th</sup> September 2005. Condition 15 requires full details of the proposed window design.

On the basis of the drawings submitted it is considered that the details of the window design are acceptable. Refer drawings *AP* [3110] 020-023 and *AP* [3110] 001-018. A typical window comprises a 'expanded metal mesh' panel and glazing unit set within an overall frame. Refer drawing *AP-130*. The expanded metal panel is made from steel and will be galvanised and then polyester powder coated. The proposed colour is RAL 110 70 70 (or equivalent) – which is green to match what is illustrated on the drawings and is to match the opening coloured panel sitting behind the mesh. Refer *Photo Sheets 1-4* for illustration of the proposed expanded metal panel in terms of profile and visual appearance, but not proposed colour.

It should be noted that a minor revision is proposed to the external 'opening door to consulting rooms' on the ground floor elevations. Refer architect's correspondence dated 20<sup>th</sup> September 2007. During the course of detailed design, it has become apparent that a transom will need to be introduced, on the basis that an aluminium door of this nature will not span the full dimension between the floor and ceiling. Revised drawings indicate the incorporation of a fan light over the opening element to these external doors. Refer drawings *A505 AP 140, 141, 142, 145, 146, 147 and 148*. This is acceptable and is not considered to compromise the original design integrity of this element of the facade.

As part of the Section 106 Agreement attached to the original planning permission, an established local resident's working group is to be consulted throughout the design/planning process. It is acknowledged that on the basis of discussions between the architect and this working group, no objections were raised with respect to this particular specification.

On the basis of the above comments and assessment, it is considered that Condition 15 be discharged accordingly.
