- 1 You are reminded that conditions: 2 materials, 3 on-site mock up of proposed facing materials, 4 slab levels, 5 details of hard/soft landscaping, 6 timescales and quality for delivering landscaping, 9 acoustic report, 14 (in part) archaeology, 21 sustainable drainage, 22 site drainage systems, 23 (in part) contaminated land, 25 refuse storage/recycling, 31 (in part) impact on terrestrial television reception and 35 (in part) Crossrail considerations, of planning permission granted on 4/10/2006, App No 2005/0259/P, are outstanding and require details to be submitted.
- 2 You are advised that in order to fully discharge conditions 5 and 6, the sumission of information including the following is required: a) the amount of new trees/plants to be planted including full planting specifications (e.g. species and size) and photo examples, b) the design and type of materials to be used for the paving within the courtyard area which clearly defines the space as a transition from the public highway, c) design statement and d) montage (photos) of samples of materials to be used on the buildings. This would need to be contained within a full and detailed landscape strategy to be agreed in writing with the local planning authority.
