The Heath nearby is popular for local pet owners. They would


- provide jobs,

The basement will be used for performing medical and surgical procedures. Part of the bottom floor will be used for storage and a kitchenette. The whole bottom floor is presently used for storage.

There is adequate metered and permit parking in the area. They are hoping to see 20 clients a day which equates to less than 2 people per hour. Some of these people will be visiting other shops in the parade anyway. The current business here probably generates an equivalent amount of traffic.

This will be a branch surgery with the main one having been established 10 years ago in a shopping parade next to a restaurant and optometrist in Crouch End. Pets will be transported from Hampstead to Crouch End for over night stay as there are staff there to do night time checks. The basement will be sound proofed. Both the above will prevent any potential for noise. Clinical waste will be stored according to regulations stipulated by the Health and Safety Executive and collected by Cambridge Pet Crematorium. There is absolutely no concern about smells. There are none. Restaurants in the parade certainly generate noise (extractor fans) and smells (garbage and food).

The clinic will contribute towards the character of the area, provide employment and provide a much needed independent business for the local population.
